ORGANIZATION

151 Legal Counsel

The Association will secure legal advice and counsel in accordance with North Carolina law and such other advice as may be required for the purpose of conducting the business and affairs of the Corporation. The Board shall pay the costs and expenses of legal counsel from the funds of the Association.

152 COMMITTEES

A member of the Board appointed to a committee shall serve a term of one (1) year, or until the next annual meeting of the Board of Directors.

Standing and Ad Hoc committees of the Board shall, when specifically charged to do so by the Board, conduct studies, make recommendations to the Board, and act in an advisory capacity, but shall not take action on behalf of the Board. Committees shall be appointed only when there is a definitive function to be performed. A Board member may request (or refuse) appointment to a committee;

Refusal to serve on any one committee shall not be grounds for lack of appointment to another committee;

The Board shall make every effort to ensure that the makeup of an advisory committee is as truly representative of the Holly Forest Association as possible.

The Board shall have the sole power to dissolve any of its advisory committees and shall reserve the right to exercise this power at any time during the life of any committee.

However, no Committee shall be dissolved prior to the Committee's report having been submitted to and discussed with the Board at the first available regular meeting. Article V, 1(h) HF By-Laws.

Nominating Committee
