

## President's Message

- Holly Forest -

Presidents Day, 2023! The start of the New Year for the Holly Forest Board of Directors (BOD). February 21st is the first Board meeting of the new year with much important work ahead of us. No matter where you live the weather this past year has been "interesting". Here in the mountains of Western North Carolina, mother nature can't seem to make up her mind, warmer than normal / snow and cold / rain, what will tomorrow bring?

For your BOD this year, the answer is ROADS! Last year, the weather revealed that the true state of many roads and culverts throughout Holly Forest needed attention. Former Board member John Daly worked hard driving throughout the community assessing what was needed to bring the roads back to what they should be. He brought his findings to the Board with his suggestions, the Board listened, there was much discussion, a plan was decided upon, and the initial actions were taken. We soon found out we had a big obstacle to overcome - money! How could we accomplish everything that needed to be done without dramatically raising fees or implementing a special assessment? The answer is a five-year plan for attacking the worst problems first and then prioritizing these problems from worst to least. This process will not only take time, but it will also take your understanding of prioritized items to complete and their timeframe as well as your patience.

Last year taught us a few very important things:

(1) The BOD must communicate better with you in terms of what the HOA is working on and how much it will cost;

- (2) Many of the culverts under our roads are 40+ years old and made of metal and metal rusts! There is a process, however, that allows us to line these culverts with a concrete-like material that will reinforce the culvert. While not inexpensive, this process is much less expensive than digging up a road, replacing everything, and then rebuilding the road.
- (3) Thanks to COVID and inflation the cost of paving one mile of asphalt has risen 400% in the past two years.

I am sure other problems will face the BOD this coming year and we will work on solving those problems in ways that are the most beneficial for you, the HOA member! One last thing, there are several Board seats coming vacant this year, think about what you can do to help Holly Forest. The annual meeting, scheduled for August 3, is a great place to announce that you want to serve! Nominations are due by June 15. There are more details in this newsletter.

# Treasurer's Report

Our dues collection rate through December 31, 2022 was 99.9% of budget which is comparable to 2021.

In 2022, we only did a small amount of paving which was on Black Oak Drive. We used a new paving technique called "mill & fill" and "crack seal" which does not produce an attractive result but does maintain the integrity of the road and may possibly extend our paving interval. Currently, most of our 75 roads are in good condition.

Most of our 2022 road work consisted of addressing our "culvert crisis." We have over 300 culverts in Holly Forest; many of which were constructed 40 or 50 years ago and are now failing. We have been using a new sleeving technique which provides a more durable culvert at a lower cost. In 2022, we started inspecting all culverts prior to paving and inspected over 60 of our 300 culverts.

The substantial cost increases for our paving, patching and road infrastructure projects required us to increase 2023 assessments by \$102/lot from \$748 to \$850 or 13.6% which is our largest increase since 2010.
