# APPROVAL OF THE MINUTES

Don Terrill presented the 2022 Annual Meeting Minutes for approval. Hearing no changes, he requested for a Motion from the floor to approve the minutes as presented.

As part of the President's Report Marva Jennings provided an update on the road projects.

# FINANCIAL REPORTS 2022 Audit Report

Terry Andersen of Carland & Andersen, Inc. reviewed the Association's 2022 audit report. It was noted any owner who does not have a copy of the audit would be able to obtain one after the meeting adjourned.

# 2023 YTD Review

Mr. Hill provided a brief review of the Association's collections to date reporting the overall the Association was in good financial condition. The dues collection rate for all of 2022 was 99.9% of the budgeted amount. Bad debt and delinquencies are still 14%. The collection rate as of May 2023 is 98% of budget. In anticipation of our substantial increase in paving expenses the Board increased the 2022 dues by 4.6% and ended the year with a modest cash surplus to carry over into 2023. As a result of the potential paving projects, the 2023 dues increased by 13.6%.

# **ECC REPORT**

Christa Pankey, ECC Chairperson, provided an overview of the responsibilities of the ECC. She reminded those in attendance of the importance of notifying Management of any home additions and tree trimming. In closing, she thanked the Board for all their hard work and support of the ECC.

# **UNFINISHED BUSINESS**

There was no Unfinished Business to come before the membership.

# **NEW BUSINESS**

President Terrill updated the owners in attendance on the revised Short-Term Renter Policy pertaining to fire pits.

# **Election results**

President Terrill announced the results of the 2023 Board Election noting there was four open Board Seats with three candidates. John Hill, Melissa McKinnon, and Richard Zacher were re-elected. There were also several write-in candidates with Chris Guttormassom receiving the most votes filling the  $4^{\rm th}$  open seat.

President Terrill reminded the owners that if they are serious about being on the Board to submit an application during the nomination process so their names can be listed on the ballot.
