Holly Forest residents welcome to 2024! Another exciting year for Holly Forest and your HOA.




We continue to work on our road repair schedule as the weather improves, allowing our contractors to repair culverts and road surfaces.

Association Update

Our dues collection rate for 2023 was 101.29% of budget, which is slightly higher than 2022. Total operating fund revenue was \$36k over budget and total operating expenses were \$66k under budget for a net positive budget effect of \$102k. Collection of prior year maintenance fees, plus interest and penalties, accounted for \$30k of the extra revenue. Substantial budget savings on grounds and landscaping and snow removal accounted for most of the expense decrease. Due to the total positive effect on the budget we ended the year with a cash surplus of \$121k in the operating fund compared to \$27k in 2022.

The reserve fund ended 2023 with a net profit of \$49k since our paving expense was \$48k under budget. As a result the reserve had a cash surplus of \$63k compared to \$7k in 2022.

Our Disaster Recovery cash account has a \$208k balance so we're well positioned for any emergency storm repairs to our roads and infrastructure.

Everyone is aware of the major increases in our paving and culvert repairs over the last two years. Our road committee, after reviewing the results of other associations' road projects, has determined that we can possibly extend our paving interval by four to six years by using a "mill & fill" and "crack seal" process for our roads. Currently, none of our seventy-five roads need paving. We will begin applying the new process to our roads which should maintain the integrity of the roads while extending the service life at a substantially lower cost.

We are also using a new sleeving technique for repairing culverts which actually provides a more durable culvert at a lower cost. In 2022 we started inspecting all culverts prior to paving. So far we have inspected over sixty of our three hundred old corrugated metal culverts.

Due to the substantial increases in our paving and road infrastructure projects it was necessary to increase the 2024 assessments from \$850 to \$960 or a 12.95% increase.


