# **President's Letter**

### Holly Forest Owners,

Instead of the usual President's letter updating you on our activities over the previous year, I am sending the following from Paul Robshaw from Vision Cashiers. He is on a mission to get these items in the hands of as many of us as possible. Before getting to Paul's message, I want to share the experience of one of our neighbors in HF 6. A couple of weeks ago his wife experienced symptoms of a heart attack. He called 911 and the response from the new Rescue Squad facility on HWY 64 took 20+ minutes in light morning traffic.

### From Paul:

### This letter is about saving lives.

Recently a group in Cashiers took the **CPR course** at the **Glenville-Cashiers 911 Rescue Squad**. Here is what was learned:

• Anyone, even children, can have sudden cardiac arrest.

• Heart disease is the biggest cause of emergencies and owning a defibrillator is critical to saving lives.

• If we've learned anything from the recent storm, we need to be prepared for emergencies.

• When one has a sudden cardiac arrest event, they have 4 minutes to restart the heart or irreversible brain damage can occur and death can happen in about 8 minutes. It takes 911 anywhere from 6-12 minutes to get there so restarting the heart is critical, in the moment, as you wait for 911 to arrive and stabilize the patient.

We took a poll of friends to see how many owned a defibrillator and were shocked to learn that few do. Probably because they are expensive (retail at about \$1,700+). Also, people think they don't know what to do with it when an event happens. (A surprise is that the device has a voice and walks one through every step of the way.)

Vision Cashiers sought and met the largest distributor in the nation for Philips, the manufacturer. We explained that Vision Cashiers is a non-profit in Cashiers doing great things for the betterment of the community. We explained that it is sponsoring a major community campaign to get people to prepare for emergencies.

We wanted to receive a major discount to convince people to buy them and negotiated a cost of \$853 including shipping to Cashiers and no sales tax.

We asked if they have any other products the home should have, and they said two:

### 1. A first aid kit

# 2. A choke recovery device (replaces the Heimlich maneuver)

Each of these retail for \$45 and \$69 and we secured a discount to \$32 and \$60.

We have also prepared a summary of tips and videos and will send them to you if you decide to participate. Plus, we have worked with the new Rescue Squad (911) on 64 to provide CPR courses monthly. The cost is \$35, and sessions are being held monthly. If interested, you can sign up by clicking here> https://www. glenvillecashiersrescuesquad.org/vccs-cpr

Vision Cashiers is doing this as a community service with no markup. Please seriously consider the purchase, but there is no obligation. You can order any number of each device. They would be a great gift to your children. The distributor can ship the entire order for a nominal charge (\$15) anywhere in the country. In general, we receive shipments in Cashiers for \$3 per defibrillator and distribute from there.

If you are interested, please email Paul Robshaw (paulrobshaw@me.com) with what you would like to purchase. The distributor requires payment prior to shipping so Vision Cashiers wires the funds, and we ask you to send a check for your purchases to Vision Cashiers to reimburse it for the payment. Feel free to pass this offer on to anyone you care about. It's all about saving lives.

# **Treasurer Report**

Our dues collection rate for 2024 was 99.62% of budget, which is slightly less than 2023. Total Operating Fund revenue was \$121k over budget, and total Operating Expenses were \$1,500 under budget, for a net positive budget effect of \$122k.

Collection of prior year Maintenance Fees, plus interest and penalties, totaled \$151k, of which \$125k was for Wyndham's delinquent fees. The substantial increase in Operating Revenue permitted us to cover the Helene storm clean-up expenses without having to use any of the cash from our Disaster Recovery Account.

The Reserve Fund revenue was \$14k over budget and our paving and infrastructure expenses were \$68k under budget, for a net positive budget result of \$82k.

Our Disaster Recovery cash account has a \$211k balance so we are well prepared for any emergency storm repairs to our roads and infrastructure.

The net result of some good management enabled us to end the year with a \$245k cash surplus in the Operating Fund and a cash surplus of \$188k in the Reserve Fund which permitted us to limit our 2025 dues increase to \$48/lot or 5% from \$960 to \$1,008.

# **Important Reminders**

### **1. Exterior Renovations**

If you are planning any exterior renovations, including but not limited to siding replacement, painting, roofing, landscaping improvements, paving, or additions, please contact the Capital Vacations Management office. You can reach us at 828-743-7667 or visit us in person at our office located inside the Red Bird Golf Pro Shop at 127 Cherokee Trail, Sapphire, NC 28774. It is important to obtain prior approval before beginning any exterior work to ensure compliance with community guidelines.

### 2. Exterior Lighting

When selecting and placing exterior lighting, please be mindful of your neighbors. All exterior light fixtures must be fully shielded or hooded, pointed downward, and positioned in a way that prevents the lighting footprint from being directly visible from other properties or public roadways.

### 3. Wildlife

Our community is fortunate to share space with a variety of wildlife, and we encourage everyone to be respectful and mindful of their presence. While it can be tempting to interact with or feed wild animals, we strongly discourage feeding wildlife. Feeding wild animals can disrupt their natural behaviors, create dependency on humans, and may attract unwanted visitors to your property.

To maintain a safe and balanced environment for both residents and wildlife:

- Avoid leaving food outside, including pet food, birdseed, or open trash, as these can attract animals.
- Secure garbage cans with bearproof lids to prevent wildlife from scavenging.
- Observe wildlife from a distance and allow them to remain undisturbed in their natural habitat.

### 4. Culvert Maintenance Reminder

With the arrival of spring and the increase in rainy days, we ask that you check to ensure your driveway culverts remain clear and unblocked to allow for proper stormwater drainage.
